Course Description:

In order to get a better understanding of some of the major strands of contemporary normative ethics, we will look closely at some important works from within each of these strands. Although the works were selected as representatives of traditions that they help found, we will not read them as such. Instead, we will read them as much as possible on their own terms. The works will include: Sidgwick *The Methods of Ethics* (selections); Korsgaard, *Sources of Normativity*; MacIntyre, *After Virtue*; Scanlon, *What We Owe to Each Other*; and Broome, *Weighing Goods*.

Requirements:

In this class, there will be two papers. A short paper (6-8 pages) and a longer seminar length paper (12-15 pages). In addition, twice per semester you will be responsible for being a "class presenter". A presenter has two main jobs. She starts the class with a very brief introduction of the material, and she raises the first question. The question must be textual! In other words, you must find a difficulty in the text and propose a brief answer to it. An example might be: "Sidgwick dismisses ultra-intuitionism on p. 95, but he seems to revert back to it on p. 123." Since there will be two presenters per day. You will present as a group and be graded as a group.
